IT COULD BE FOR THE JULY  $4^{\text{TH}}$  PUSH FOR BEEF. DAILY BEEF SALES ARE FOR 1 TO 21 DAYS AND RETAILERS BECAUSE OF THE SMALLER SUPPLIES THIS YEAR LIKELY ARE BUYING THE PRIMAL SECTIONS MADE INTO STEAKS.

AS OF JUNE 6, 2024 THE 5 DAY NEGOTIATED STEER PRICE WAS \$188.96. ON JUNE 6, 2024 JUNE LIVE CATTLE SETTLED AT \$181.82. FIRST NOTICE DAY IS MONDAY JUNE  $10^{TH}$ .

A FEW CATTLE SOLD THURSDAY IN THE MIDWEST AT \$188.00 BUT THEY WERE LIGHT. MORE CATTLE SOLD IN THE SOUTHWEST AND KANSAS AT 185.00, \$1.00 LOWER FROM LAST WEEK, REGARDLESS OF GRADE OR SEX. FEEDLOTS ARE HOLDING OUT FOR STEADY TO \$1.00 HIGHER BECAUSE OF THE HIGHER BEEF MARKET.

IF CASH CATTLE ARE \$1.00 LOWER, IT WOULD BRING CASH AND JUNE FUTURES NEARER TO A CONVERGENCE.

CONSUMERS TAKING SUMMER VACATIONS WILL BE A REASON HOW CONSUMERS SPEND DISPOSABLE INCOME OVER THE NEXT 2 MONTHS. OTHER THAN 4<sup>TH</sup> OF JULY WHEN BEEF BUYING PICKS UP, THE HEAT OF THE SUMMER ALSO DICATATES WHAT CONSUMERS BUY AND THEY DON'T BUY CUTS THAT HEAT UP THE HOUSE.

Sterling Marketing uses the Comprehensive Beef Cutout Value reported by USDA. I have included a document that explains this cutout value. I looked at this value about 4 years ago and compared the beef packer margin values from my Choice-Select Adjusted value and this Comprehensive value. There was little difference. However, over the past few weeks, the difference has become significant. I believe this is because the mix of cattle slaughtered is increasingly includes higher valued cattle – i.e., Prime, Upper 2/3 Choice, and Branded Program cattle. In addition, it includes the formula-priced cattle. Using just the Choice and higher grade and Select grade to generate the cutout does not reflect this important difference in the quality of cattle which in turn is definitely a driver to the notable improvement in beef demand over the past year.

BEEF: NET SALES OF 14,500 MT FOR 2024 WERE DOWN 8 PERCENT FROM THE PREVIOUS WEEK AND 11 PERCENT FROM THE PRIOR 4-WEEK AVERAGE. INCREASES WERE PRIMARILY FOR SOUTH KOREA (6,000 MT, INCLUDING DECREASES OF 400 MT), JAPAN (3,400 MT, INCLUDING DECREASES OF 500 MT), MEXICO (1,400 MT, INCLUDING DECREASES OF 100 MT), CANADA (1,000 MT, INCLUDING DECREASES OF 100 MT), AND TAIWAN (900 MT, INCLUDING DECREASES OF 200 MT). EXPORTS OF 15,300 MT WERE DOWN 5 PERCENT FROM THE PREVIOUS WEEK AND 6 PERCENT FROM THE PRIOR 4-WEEK AVERAGE. THE DESTINATIONS WERE PRIMARILY TO JAPAN (4,300 MT), SOUTH KOREA (3,200 MT), CHINA (2,300 MT), TAIWAN (1,500 MT), AND CANADA (1,300 MT).

PORK: NET SALES OF 29,900 MT FOR 2024 WERE DOWN 33 PERCENT FROM THE PREVIOUS WEEK, BUT UP 3 PERCENT FROM THE PRIOR 4-WEEK AVERAGE. INCREASES PRIMARILY FOR CHINA (8,900 MT, INCLUDING DECREASES OF 100 MT), MEXICO (8,300 MT, INCLUDING DECREASES OF 300 MT), JAPAN (3,400 MT, INCLUDING DECREASES OF 300 MT), SOUTH KOREA (2,800 MT, INCLUDING DECREASES OF 500 MT), AND CANADA (1,800 MT, INCLUDING DECREASES OF 600 MT), WERE OFFSET BY REDUCTIONS FOR TAIWAN (200 MT). EXPORTS OF 34,400 MT WERE DOWN 1 PERCENT FROM THE PREVIOUS WEEK, BUT UNCHANGED FROM THE PRIOR 4-WEEK AVERAGE. THE DESTINATIONS WERE PRIMARILY TO
