United States Cattle on Feed Up 1 Percent

Cattle and calves on feed for the slaughter market in the United States for feedlots with capacity of 1,000 or more head totaled 11.2 million head on September 1, 2024. The inventory was 1 percent above September 1, 2023

Placements in feedlots during August totaled 1.98 million head, 1 percent below 2023. Net placements were 1.92 million head. During August, placements of cattle and calves weighing less than 600 pounds were 395,000 head, 600-699 pounds were 305,000 head, 700-799 pounds were 435,000 head, 800-899 pounds were 485,000 head, 900-999 pounds were 265,000 head, and 1,000 pounds and greater were 90,000 head.

Marketings of fed cattle during August totaled 1.82 million head, 4 percent below 2023.

Other disappearance totaled 54,000 head during August, 2 percent below 2023.

The report was right in line with expectations. The report won't impact markets on Monday. Traders are focusing on falling boxed beef prices versus anticipation of increasing demand for beef going into the 4th quarter.

THE COMING WEEK CATTLE PRICES WILL DEPEND ON HOW BOXED BEEF PRICES DO. ON AUGUST 23RD CHOICE BEEF WAS \$317.34 COMPARED TO THE CURRENT PRICE AT \$300.19 AND SELECT BEEF WAS \$300.46 COMPARED TO THE CURRENT PRICE \$288.59. PACKERS ARE KEEPING SLAUGHTER DOWN WHILE THEY ARE LETTING WEIGHTS INCREASE PLUS CONTINUING TO IMPORT INCREASING AMOUNTS OF BEEF.

OCTOBER 2024 LIVE CATTLE SETTLED ON SEPTEMBER 20, 2024 AT 182.47. THE 5 DAY NEGOTIATED STEER PRICE WAS \$182.97.

PACKERS PAID \$2.00 HIGHER LAST WEEK FOR CASH CATTLE ON LIMITED AMOUNT SUGGESTING THE COMING WEEK IS GOING TO BE ANOTHER LIGHT KILL. CATTLE IN THE MIDWEST WERE MOSTLY \$183.00 TO \$185.00 WITH A FEW LIVE DELIVERED CATTLE UP TO \$187.00 DRESSED CATTLE WERE MOSTLY \$292.00. CATTLE IN THE SOUTHWEST WERE MOSTLY \$183.00. TEXAS TOTAL NEFGOTIATED SALES WERE ONLY 2,350 HEAD.

SLAUGHTER FOR THE WEEK WAS 610,00 HEAD DOWN 10,000 FOR THE WEEK AND 16,000 FEWER THAN A YEAR AGO. THE CME BOXED BEEF INDEX FELL \$3.54.

BEEF PRICES ARE DROPPING DAY AFTER DAY. MORE BEEF IS BEING MOVED ON THE DAILY MARKET. PACKERS WILL BACK OFF BUYING CATTLE. PACKERS WOULD RATHER SEE CATTLE WEIGHTS INCREASE THAN BUY EXTRA CATTLE. BEEF WHOLESALERS WANT LOWER U.S. BEEF PRICES AND WILL IMPORT MORE BEEF VERSUS BUYING MORE U.S. BEEF. SHOWLIST FEEDLOTS EXPECT HIGHER CASH TRADE THIS WEEK FEELING PACKERS ARE SHORT BOUGHT. MANY FEEDLOTS WILL KEEP CATTLE IN THE FEEDLOT IF THEY WON'T GET IT AND THE PACKER WILL BE FINE WITH FEEDLOTS KEEPING CATTLE. BEEF PRICES KEEP ON GOING DOWN SO AS LONG AS PACKERS CAN MEET THEIR CONTRACT BEEF ORDERS AND DON'T HAVE EXTRA BEEF TO SELL ON HE DAILY MARKET, THEY WON'T COMPLAIN IF FEEDLOTS HOLD CATTLE. A FEW LESS CATTLE WON'T HURT THE PACKER.

AS OF SEPTEMBER 17, 2024, DRESSED STEER AND HEIFER CARCASSES AVERAGED 912.6 POUNDS, UP 5.0 POUNDS FROM PREVIOUS WEEK, AND <u>UP 33 POUNDS FROM A YEAR AGO</u>. THE GRADING PERCENT AS OF 09/17/2024 WAS 82.6% COMPARED TO PREVIOUS WEEK AT 83.4% BUT UP 3% OVER A YEAR AGO.

Sterling Marketing uses the Comprehensive Beef Cutout Value reported by USDA. I have included a document that explains this cutout value. I looked at this value about 4 years ago and compared the beef packer margin values from my Choice-Select Adjusted value and this Comprehensive value. There was little difference. However, over the past few weeks, the difference has become significant. I believe this is

because the mix of cattle slaughtered is increasingly includes higher valued cattle – i.e., Prime, Upper 2/3 Choice, and Branded Program cattle. In addition, it includes the formula-priced cattle. Using just the Choice and higher grade and Select grade to generate the cutout does not reflect this important difference in the quality of cattle which in turn is definitely a driver to the notable improvement in beef demand over the past year.
