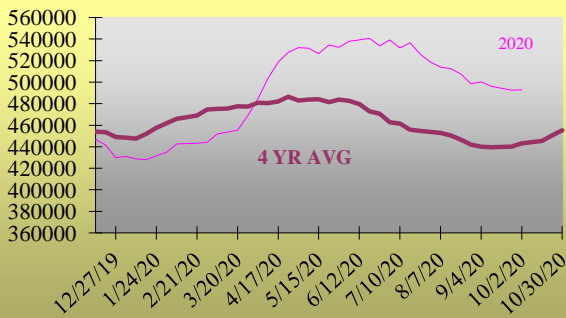

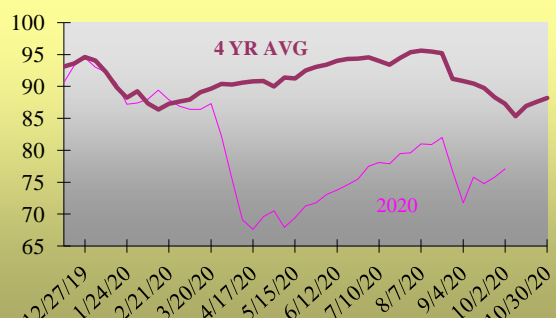

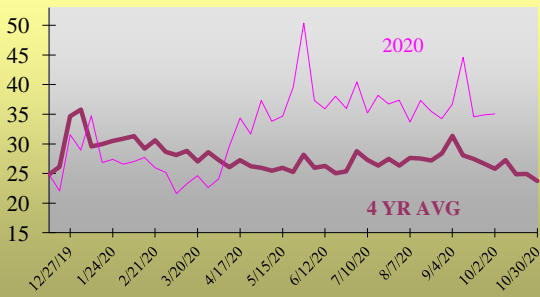

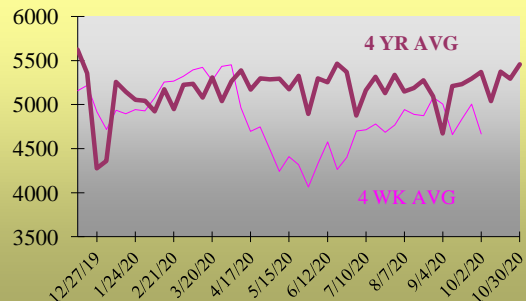

HEATING OIL DEMAND



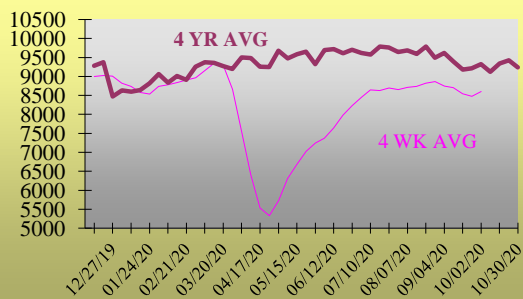

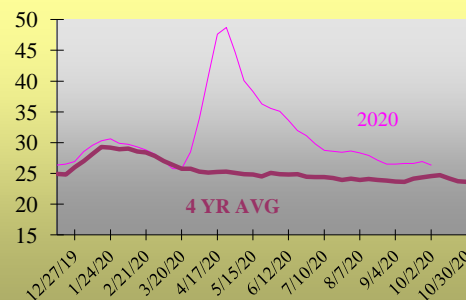
