

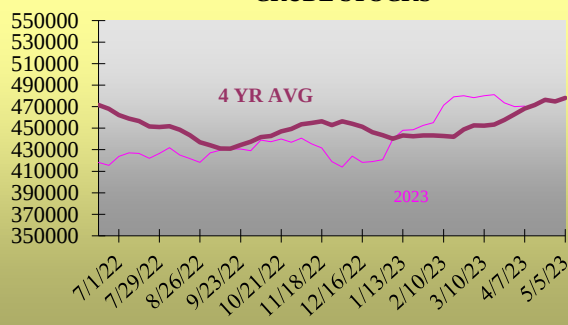

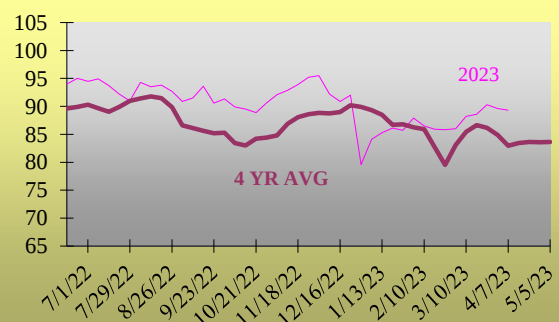

REFINERY PERCENT OPERATED



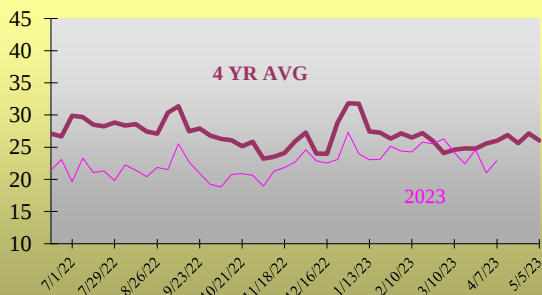

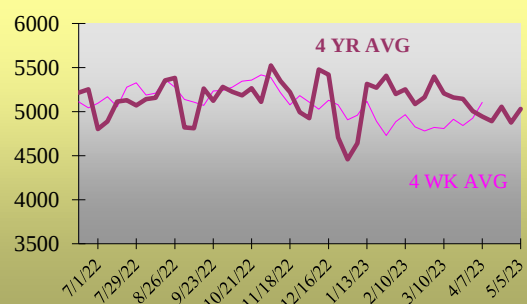

HEATING OIL DAYS SUPPLY



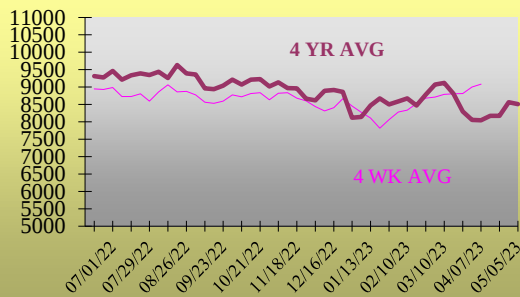
HEATING OIL DEMAND



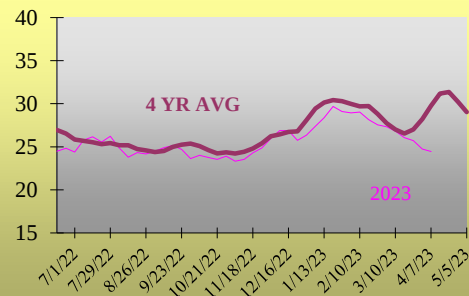
